4-2. Describe how the CoC determined that this project should be reduced and include the date the project applicant was notified of the reduction. (limit 750 characters)

At its September 7, meeting, the CoC Rating and Ranking Subcommittee identified that the MATCH PSH project has underspent by 30% in the previous year. Because significant underspending is one of the reasons for reallocation in the CoC's Reallocation Policy, the subcommittee recommended that \$83,603 be reallocated to new PSH projects. In making this recommendation, the subcommittee determined there was no risk that MATCH would need to reduce its units or that any MATCH residents would lose their housing. The CoC Board accepted the subcommittee's recommendation at its September 14, 2022 meeting. The project applicant was notified in writing of this decision on September 15, 2022.

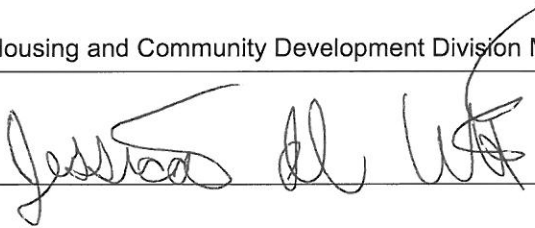

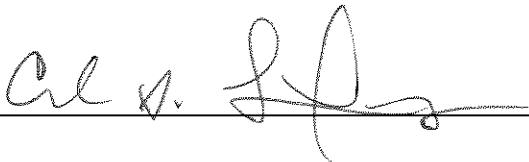
